COVID-19: PASSENGER RESTRICTIONS

- E)** ALL PASSENGERS, CREW MEMBERS AND OPERATIONAL STAFF ARRIVING TO BOSNIA AND HERZEGOVINA BY AIRCRAFT MUST COMPLETE A PUBLIC HEALTH PASSENGER LOCATOR FORM (PLF).  
ALL PLFS MUST BE COLLECTED BY THE CREW, CHECKED AND HANDED OVER TO THE RAMP AGENT UPON LANDING.  
ALL AIRLINE OPERATORS ARRIVING IN BOSNIA AND HERZEGOVINA ARE REQUIRED TO INFORM THEIR PASSENGERS BEFORE BOARDING THE AIRCRAFT WITH FOLLOWING INFORMATION:  
-IT IS TEMPORARY FORBIDDEN TO ENTER BOSNIA AND HERZEGOVINA TO FOREIGN NATIONALS. IN ACCORDANCE WITH THE LAW ON FOREIGNERS, THE DECISION ON REFUSAL OF ENTRY INTO BOSNIA AND HERZEGOVINA WILL BE DELIVERED TO ALL PASSENGERS.  
-THIS MEASURE IS NOT APPLICABLE TO BOSNIAN, SERBIAN, CROATIAN AND MONTENEGRIN CITIZENS,  
- CITIZENS OF EU MEMBER STATES AND SCHENGEN MEMBER STATES AS WELL AS FOREIGNERS WHO HAVE A MULTIPLE SCHENGEN VISA OR A VISA OF THE EUROPEAN UNION OR AN APPROPRIATE RESIDENCE PERMIT IN THE EUROPEAN UNION AND THE SCHENGEN AREA, ARE ALLOWED TO ENTER AND STAY IN BIH, IF THEY HAVE A CERTIFICATE OF NEGATIVE SARS-COV-2 VIRUS TEST, NOT OLDER THAN 48 HOURS UNTIL THE TIME OF ENTRY (CITIZENS OF THE REPUBLIC OF CROATIA ARE EXEMPTED),  
-THIS MEASURE IS NOT APPLICABLE TO FOREIGNERS WHO ENTERS BOSNIA AND HERZEGOVINA DUE TO BUSINESS OBLIGATIONS, IF CAN PROVIDE AN INVITATION LETTER FROM A LEGAL ENTITY FROM BOSNIA AND HERZEGOVINA THAT HIRES HIM IN BOSNIA AND HERZEGOVINA AND A CERTIFICATE OF NEGATIVE TEST FOR SARS-COV-2 VIRUS FROM AN AUTHORIZED LABORATORY (NOT OLDER THAN 48 HOURS FROM THE TIME OF ENTRY).  
-THIS MEASURE IS NOT APPLICABLE TO FOREIGN FAMILY MEMBERS (SPOUSE, PARENTS, CHILDREN, BROTHERS AND SISTERS) OF THE DECEASED, WHO DUE TO PRESENCE OF THE FUNERAL OF THE DECEASED MAY STAY IN BOSNIA AND

HERZEGOVINA FOR A MAXIMUM OF 72 HOURS FROM THE MOMENT OF ENTRY INTO BOSNIA AND HERZEGOVINA, NOT COUNTING THE POSSIBLE PERIOD OF ISOLATION, PROVIDED THEY HAVE EVIDENCE OF DEATH AND RELATION WITH DECEASED.

-THIS MEASURE IS NOT APPLICABLE TO MINOR FOREIGNERS ACCOMPANIED BY PARENTS OR GUARDIANS WHO ARE THE CITIZENS OF BOSNIA AND HERZEGOVINA.

-THIS MEASURE IS NOT APPLICABLE TO A FOREIGNER WHO IS A SPOUSE OF A CITIZEN OF BOSNIA AND HERZEGOVINA.

-THIS MEASURE IS NOT APPLICABLE TO CITIZENS OF BOSNIA AND HERZEGOVINA WHO HAVE DUAL CITIZENSHIP .THEY MAY ENTER BOSNIA AND HERZEGOVINA WITH ID CARD ISSUED BY THE COMPETENT AUTHORITY OF BOSNIA AND HERZEGOVINA, REGARDLESS OF THE MANNER OF ENTRY INTO ANOTHER COUNTRY FROM WHICH THEY RETURN.

-THIS MEASURE IS NOT APPLICABLE TO THE AIRCRAFT CREW AND CABIN CREW WHOSE FINAL DESTINATION IS BOSNIA AND HERZEGOVINA.

-THIS MEASURE IS NOT APPLICABLE TO DIPLOMATIC - CONSULAR STAFF ACCREDITED (RESIDENT) IN BOSNIA AND HERZEGOVINA, WITH THE OBLIGATION TO COMPLY TO ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES OF BOSNIA AND HERZEGOVINA (EPIDEMIOLOGICAL AND HEALTH SERVICES).UPON ENTERING THE TERRITORY OF BOSNIA AND HERZEGOVINA, DIPLOMATIC-CONSULAR STAFF MUST POSSESS AND PRESENT DIPLOMATIC CARD OF THE MINISTRY OF FOREIGN AFFAIRS OF BOSNIA AND HERZEGOVINA (TYPE D,MO,K,S,PO,PK,PP) AND A VALID PASSPORT.

-THIS MEASURE IS NOT APPLICABLE TO MEDICAL STAFF ENTERING BOSNIA AND HERZEGOVINA FOR PROFESSIONAL ENGAGEMENT.

-THIS MEASURE IS NOT APPLICABLE TO PERSONS REQUIRING URGENT MEDICAL TREATMENT.

-THIS MEASURE IS NOT APPLICABLE TO MEMBERS OF MILITARY FORCES OF NATO STATES AND OTHER STATES WHICH PARTICIPATE IN THE PARTNERSHIP FOR PEACE, NATO HQ MEMBERS AND EUFOR IN BOSNIA AND HERZEGOVINA.

-THIS MEASURE IS NOT APPLICABLE TO HEADS OF STATE AND MEMBERS OF THEIR DELEGATIONS WHOSE ARRIVAL AND DEPARTURE HAVE BEEN ANNOUNCED TO THE BIH BORDER POLICE THROUGH DIPLOMATIC CHANNELS OR THROUGH PROTOCOLS OF THE COMPETENT BIH AUTHORITY.

-THIS MEASURE IS NOT APPLICABLE TO FOREIGN PASSENGERS RESIDING OR TEMPORARILY RESIDING IN BOSNIA AND HERZEGOVINA.

-THIS MEASURE DOES NOT APPLY TO CONSULAR REPATRIATION OF NATIONALS OF BOSNIA AND HERZEGOVINA OR FOREIGN NATIONALS WHEN LEAVING BOSNIA AND HERZEGOVINA IN ACCORDANCE WITH THE RELEVANT PROTOCOL.

-ALL SANITATION AT AIRPORTS IS IMPLEMENTED IN ACCORDANCE WITH THE DECISIONS OF THE ENTITY MINISTRIES OF HEALTH.
