E) COVID-19: PASSENGER RESTRICTIONS

FOREIGN CITIZENS WHO MEET THE CONDITIONS FOR ARRIVAL IN BOSNIA AND HERZEGOVINA PRESCRIBED BY THE LAW ON ALIENS, CAN ENTER BOSNIA AND HERZEGOVINA UPON PRESENTATION OF :

- NEGATIVE RESULT OF THE PCR TEST OR RAPID ANTIGEN TEST FOR SARS-COV-2 VIRUS, WHICH IS NOT OLDER THAN 48 HOURS IF IT COMES FROM EUROPEAN COUNTRIES, AND IF IT COMES FROM OTHER COUNTRIES THAT PCR TEST IS NOT OLDER THAN 72 HOURS UNTIL ARRIVAL AT THE BORDER CROSSING OF BOSNIA AND HERZEGOVINA,
- VACCINATION CERTIFICATE FOR A PERSON WHO RECEIVED A SECOND DOSE OF COVID-19 VACCINE MORE THAN 14 DAY BEFORE THE DAY OF ARRIVAL AT THE BORDER CROSSING OF BOSNIA AND HERZEGOVINA OR WAS VACCINATED WITH ONE DOSE BEFORE 14 DAYS AND MORE THAN THE DAY OF ARRIVAL AT THE BORDER CROSSING OF BOSNIA AND HERZEGOVINA, IF IT IS A VACCINE THAT IS GIVEN IN A SINGLE DOSE,
- CERTIFICATE ISSUED BY A DOCTOR THAT HAS OVERCOME THE DISEASE COVID-19 IN THE PAST PERIOD FROM THE 14TH TO THE 180TH DAY FROM THE DAY OF ARRIVAL AT THE BORDER CROSSING OF BOSNIA AND HERZEGOVINA.

THIS LIMITATION IS NOT APPLICABLE TO:

- CITIZENS OF MONTENEGRO, THE REPUBLIC OF CROATIA AND THE REPUBLIC OF SERBIA, WHEN THEY ENTER BOSNIA AND HERZEGOVINA DIRECTLY FROM THE COUNTRY OF WHICH THEY ARE CITIZENS, AS WELL AS THEIR MINOR CHILDREN AND SPOUSES WHO ARE CITIZENS OF OTHER COUNTRIES,
- CREW AND CABIN CREW OF THE AIRCRAFT WHOSE FINAL DESTINATION IS BOSNIA AND HERZEGOVINA,
- DIPLOMATIC AND CONSULAR STAFF AND STAFF OF INTERNATIONAL ORGANIZATIONS DURING PERFORMANCE OF THEIR OFFICIAL DUTIES, WHO, UPON ENTERING BOSNIA AND HERZEGOVINA, MUST POSSESS AND PRESENT AN APPROPRIATE VALID PASSPORT,
- CIVIL PROTECTION SERVICES AND TEAMS WHEN THEIR ENTRY INTO BOSNIA AND HERZEGOVINA IS URGENT AND IMMEDIATE,
- MEMBERS OF MILITARY FORCES OF NATO STATES AND OTHER STATES WHICH PARTICIPATE IN THE PARTNERSHIP FOR PEACE, NATO HQ MEMBERS AND EUFOR IN BOSNIA AND HERZEGOVINA,
- HEADS OF STATE AND MEMBERS OF THEIR DELEGATIONS WHOSE ARRIVAL AND DEPARTURE HAVE BEEN ANNOUNCED TO THE BIH BORDER POLICE THROUGH DIPLOMATIC CHANNELS OR THROUGH PROTOCOLS OF THE COMPETENT BIH AUTHORITY,
- FOREIGN CITIZENS TRANSITING THROUGH THE TERRITORY OF BOSNIA AND HERZEGOVINA FOR THE PURPOSE OF RETURNING TO THE COUNTRY OF RESIDENCE, WITHOUT RETENTION ON THE TERRITORY OF BOSNIA AND HERZEGOVINA,
- MINORS WHOSE PARENT IS A CITIZEN OF BOSNIA AND HERZEGOVINA, AS WELL AS A FOREIGN CITIZEN WHO IS THE SPOUSE OF A CITIZEN OF BOSNIA AND HERZEGOVINA,
- CHILDREN UNDER THE AGE OF SEVEN TRAVELING ACCOMPANIED BY A PARENT OR GUARDIAN, IF THE PARENT OR GUARDIAN HAS A NEGATIVE PCR TEST OR RAPID SARS-COV-2 VIRUS ANTIGEN TEST, OR VACCINATION CERTIFICATE OR CONFIRMATION THAT HE HAS OVERCOME THE DISEASE COVID-19
- ALIENS WITH APPROVED TEMPORARY OR PERMANENT RESIDENCE IN BOSNIA AND HERZEGOVINA, IF THEY RETURN TO BOSNIA AND HERZEGOVINA AFTER LEAVING AND STAYING ONLY IN MONTENEGRO, THE REPUBLIC OF CROATIA AND / OR THE REPUBLIC OF SERBIA, PROVIDED THAT THE TOTAL STAY IN THESE COUNTRIES DID NOT LAST LONGER THAN 48 HOURS FROM LEAVING THE TERRITORY OF BOSNIA AND HERZEGOVINA, WHICH IS PROVEN BY THE IMPRINT OF THE EXIT OR ENTRY STAMP IN THE TRAVEL DOCUMENT OF THE ALIEN.

- FOREIGN CITIZENS ARE OBLIGED TO FOLLOW AND RESPECT ALL INSTRUCTIONS AND ORDERS OF THE COMPETENT AUTHORITIES OF BOSNIA AND HERZEGOVINA, EPIDEMIOLOGICAL AND HEALTH SERVICES.)
